## Publication of a transparency notification

WDP announces having received two transparency notifications dated 4 September 2024 from BlackRock. The notification pursuant to a transaction of shares on 30 August 2024 shows the participation threshold of 7.5% has been exceeded. The notification pursuant to a transaction of shares on 2 September 2024 subsequently reports the undershoot of 7.5% in voting rights attached to shares. However, the total number of voting rights (attached to shares and to equivalent financial instruments) remains above the participation threshold of 7.5%.


