Publication of a transparency notification

(Article 14, first paragraph, of the law of 2 may 2007 regarding the disclosure of major holdings)

WDP announces that it has received two transparency notifications from BlackRock, reporting, in respect of voting rights attached to shares, an undershoot of the 7.5% participation threshold as at 13 September 2024, followed by an overshoot of this threshold as at 16 September 2024. The total number of voting rights (attached to shares and equivalent financial instruments) has always remained above the participation threshold of 7.5%.
