

Publication of a transparency notification

(Article 14, first paragraph, of the law of 2 may 2007 regarding the disclosure of major holdings)

WDP announces having received a transparency notification dated 3 October 2024 as a result of a change of control within the BlackRock group. This notification shows that BlackRock holds 7.76% of the voting rights in WDP (compared to 7.70% at the time of the previous notification) and thus remains above the participation threshold of 7.5%.

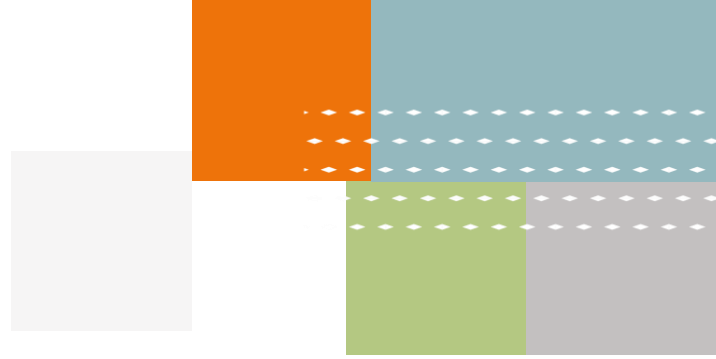

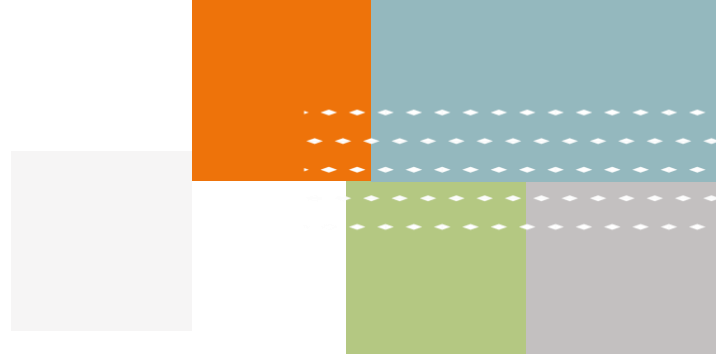
