

### Publication of a transparency notification

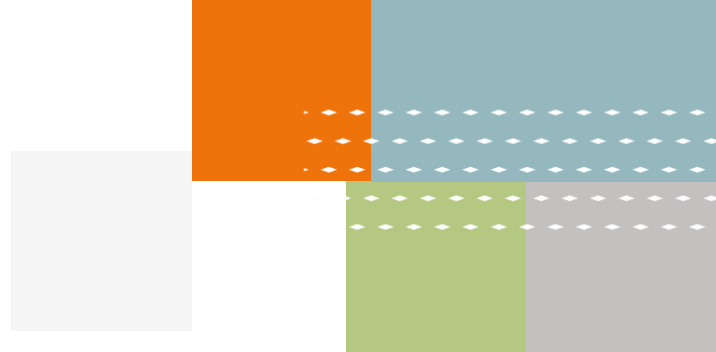
