

# Publication of a transparency notification

(Article 14, first paragraph of the law of 2 May 2007 regarding the disclosure of major holdings)

WDP announces having received a transparency notification from BlackRock dated 3 July 2025, following changes to its group structure.

BlackRock now holds 4.77% of voting rights linked to securities and 0.41% of voting rights through equivalent financial instruments. The aggregate percentage held by BlackRock (securities conferring voting rights and voting rights through equivalent financial instruments) amounts to 5.19%. The total number of voting rights (securities conferring voting rights and voting rights through equivalent financial instruments) remains below the participation threshold of 7.5%.
