With deep sadness and disbelief, the family of Jos De Pauw, the members of the Board of Directors and the entire WDP team announce the passing of Tony De Pauw, member of the board, reference shareholder and former CEO.

Tony passed away unexpectedly on the morning of Wednesday 6 August 2025, at home in Kobbegem. He was 70 years old.

More than 25 years ago, at WDP's IPO in June 1999, Tony took over the helm from his late father, founder of WDP, Jos De Pauw. With vision and entrepreneurial spirit, Tony, together with his team, built WDP into a unique, family-rooted, and European listed logistics real estate platform, with a client-centric focus at his heart. He did so both in his role as CEO and as a reference shareholder.
