



#### **PUBLICATION OF A TRANSPARENCY NOTIFICATION**

(ARTICLE 14, FIRST PARAGRAPH, OF THE LAW OF 2 MAY 2007 REGARDING THE DISCLOSURE OF MAJOR HOLDINGS)
