

**PUBLICATION OF A TRANSPARENCY NOTIFICATION**

(ARTICLE 14, FIRST PARAGRAPH, OF THE LAW OF 2 MAY 2007 REGARDING THE DISCLOSURE OF MAJOR HOLDINGS)

**WDP announces having received a collective transparency notification dated 25 July 2016 indicating that (int. al.) BlackRock Inc., BlackRock Advisors LLC., BlackRock Asset Management Canada Ltd., BlackRock Asset Management Ireland Ltd., BlackRock Asset Management North Asia Ltd., BlackRock Asset Management Schweiz AG, BlackRock Fund Advisors, BlackRock Fund Managers Ltd., BlackRock Institutional Trust Company - National Association, BlackRock International Ltd., BlackRock Investment Management (Australia) Ltd., BlackRock Japan Co. Ltd. and BlackRock (Netherlands) B.V., at 25 July 2016, by virtue of the transfer of shares at 21 July 2016, have fallen below the limit of 3%.**
