

## PUBLICATION OF A TRANSPARENCY NOTIFICATION

(ARTICLE 14, FIRST PARAGRAPH, OF THE LAW OF 2 MAY 2007 REGARDING THE DISCLOSURE OF MAJOR HOLDINGS)

**WDP announces having received a collective transparency notification dated 21 June 2016 indicating that (int. al.) BlackRock Inc., BlackRock Advisors LLC., BlackRock Asset Management Canada Ltd., BlackRock Asset Management Ireland Ltd., BlackRock Asset Management North Asia Ltd., BlackRock Asset Management Schweiz AG, BlackRock Fund Advisors, BlackRock Fund Managers Ltd., BlackRock Institutional Trust Company - National Association, BlackRock International Ltd., BlackRock Investment Management (Australia) Ltd., BlackRock Japan Co. Ltd. and BlackRock (Netherlands) B.V., hold, by virtue of the transfer of shares at 17 June 2016, 3.04% of the voting rights of the company at 21 June 2016. As such they have crossed the limit of 3%.**
